Personal Information We Collect

When you visit the Site, we automatically collect certain information about your device, including information about your web browser, IP address, time zone, and some of the cookies that are installed on your device. - "Web beacons," "tags," and "pixels" are electronic files used to record information about how you browse the Site.

Inner Care Center is not responsible for how third parties may use information collected from or about you. Inner Care Center uses social buttons provided by services like Instagram, Google+, LinkedIn, Twitter, and Facebook, and also creates advertisements on these platforms and websites. Your use of these third-party services and/or the provision of personal information is entirely optional. We are not responsible for the privacy policies and/or practices of these third-party services, and you are responsible for reading and understanding those third party services' privacy policies.

Additionally, when you make a purchase or attempt to make a purchase through the Site, we collect certain information from you, including your name, billing address, shipping address, payment information, email address, and phone number. We refer to this information as "Order Information."

How Do We Use Your Personal Information?

We collect your information when you make a purchase on our Site, over the phone and/or in person, and when you sign up to receive emails from us. We also look at how you use the Site, so that we can offer the best possible experience.

We use the Order Information that we collect generally to fulfill any orders placed through the Site (including processing your payment information, and providing you with invoices and/or order confirmations). Additionally, we use this Order Information to:

- Communicate with you;
- Screen our orders for potential risk or fraud; and
- When in line with the preferences you have shared with us, provide you with information or advertising relating to our products or services.

We use the Device Information that we collect to help us screen for potential risk and fraud (in particular, your IP address), and more generally to improve and optimize our Site (for example, by generating analytics about how our customers browse and interact with the Site, and to assess the success of our marketing and advertising campaigns).
